The cash distributions declared and paid to date are less than the current and accumulated earnings and profits of Seaspan Corporation, as forecasted based on Q3 2020 estimated earnings and profits. On such basis, the full amount of the distributions per share were paid out of current and accumulated earnings and profits and are allocated in order of the cash distributions. The basis of each share held as of the date of record should not be affected.

Note that foregoing determination is based on the 2020 forecasted earnings and profits, which are estimates and subject to change as the year progresses. The actual basis reduction, if any, will be determined once the 2020 earnings and profits computations are completed.
