



Seaspan Corporation to Offer Common Shares

HONG KONG, CHINA, Aug 13, 2007 (CCNMatthews via COMTEX News Network) --

Seaspan Corporation (the "Company") (NYSE:SSW) announced today that it plans to offer approximately 4,500,000 million common shares in a registered offering, subject to market conditions. The underwriters have been granted an option to purchase up to 675,000 additional common shares to cover over-allotment, if any. The Company intends to use the net proceeds from this offering for general corporate purposes, including repayment of indebtedness, capital expenditures, working capital and to make vessel acquisitions.

Citi and Merrill Lynch & Co. will act as joint book-running managers of the offering. Dahlman Rose & Company will act as a co-manager.

About Seaspan

Seaspan owns containerships and charters them pursuant to long-term fixed-rate charters. Seaspan's fleet of 55 containerships consists of 29 existing containerships and 26 to be delivered over approximately the next 3.5 years. The 26 vessels that Seaspan has contracted to purchase are already committed to long-term time charters averaging approximately 11 years in duration from delivery. Seaspan's operating fleet of 29 vessels has an average age of approximately four years with an average remaining charter period of approximately eight years. Seaspan's customer base consists of seven of the largest liner companies, including China Shipping Container Lines, A.P. Moller-Maersk, Mitsui O.S.K. Lines, Hapag-Lloyd, COSCO Container Lines, K-Line and CSAV.

Seaspan's common shares are listed on The New York Stock Exchange under the symbol "SSW."
